- Motion to amend to change 2.1 11. To say "Students may not receive credit for courses that are designated by the department, and approved by the senate, as regressive prerequisites for courses in which they are currently enrolled or have already received credit."
- After discussion, amendment passed unanimously by a show of hands.
- There was desire to change 2.1 10. However, it was agreed that those changes could be pursued after the motion was passed, so as not to delay the motion.
- Motion to close debate passed by show of hands.
- Vote on Core Ed Distribution Requirements
- Motion passes unanimously by a show of hands.
